**1. Objectives of the MOU**

- a) To promote and enhance academic interest between the institutes.
- b) To exchange the expertise of the institutions mutually.
- c) To promote exchange of students and research activities between the institutes.
- d) To promote cultural exchange programmes.
- e) To encourage direct contact and co-operation's between their faculties and students in different department particularly in the following discipline.
  1. Economics
  2. Education
  3. English
  4. Geography
  5. Philosophy
  6. Political Science

**2. Technical Area of collaboration**

- a) Provide Academic interactions by delivering special lecture at **Shree Shree Gour Gobind Girls' College** and **The Maharaja Bodhchandra College**.
- b) Exchange of scientific and technologies information joint publications of common results.
- c) Facilitate the hand on trainings for UG students.
- d) To exchange the visiting international delegates to each institutes mutually.
- e) Identify and invite the faculty members and researchers from other institutes to participate to conference, workshops and short-term courses.

**Declare That:**

**Shree Shree Gourgobind Girls' College and The Maharaja Bodhchandra College** manifest their intention to search an agreement to foster academic cooperation according to the following terms and conditions.

**Article 1. Shree Shree Gourgobind Girls' College and The Maharaja Bodhchandra College** agree to promote joint teaching research and other academic activities as aforesaid in the objectives and technical area of collaboration for mutual benefit to both institutes.

A Specific plan and agreement will be worked out and approved by the institutes before any such programmes or activities can be undertaken.

**Article 2.** Resources for the implementation of specific programmes may derive from either party or from external funds. However, this agreement does not oblige either party to expand any resources with the objectives herein specified unless explicitly stated otherwise in the corresponding specific agreement.

**Article 3.** This agreement will be effective for a period of five years from the date of its signing and the renovation

**Article 4.** This agreement does not imply any financial duty upon both the institutions.

**Article 5.** Either party may terminate this agreement on written notification. Such notification must be given at least six months prior to the proposed date of termination, if the present agreement is terminated, both parties must guarantee to facilitate the completion of the project and initiative already in progress.

**Article 6.** Each institution appoints coordinate for the implementation of this agreement who will be responsible for defining and organizing the programmes to be undertaken and for interaction between two intuitions.

**Article 7.** The intellectual Property Right (IPR) that arise as a result of joint research and collaborative activity under the agreement will be worked out on a case and will be consistent with officially laid down IPR policies of the two institutions.
